

**Kubota Honky Tonk Concert Ticket Giveaway Sweepstakes
Official Rules**

- **NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING.**
- **VOID WHERE PROHIBITED BY LAW.**
- **ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, ENTRANTS AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Kubota Honky Tonk Concert Ticket Giveaway Sweepstakes (“Sweepstakes”) is open only to natural persons who are legal residents and physically located in one (1) of the forty-eight (48) contiguous United States or the District of Columbia, and who are at least age of majority or older in their state/jurisdiction of residence (which is eighteen (18) in most states but is nineteen (19) in Alabama and Nebraska and twenty-one (21) in Mississippi) as of time/date of entry. Employees, officers and directors of Kubota Tractor Corporation (“Sponsor”), Realtime Media LLC (“Administrator”) and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies (collectively with Sponsor and Administrator, the “Sweepstakes Parties”), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. By participating, you agree to these Official Rules and to the decisions of the Sponsor and Administrator, which are final and binding in all respects. Void in any state not listed above and where prohibited by law, rule or regulation. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these “Official Rules” and the decisions of Sponsor, including the interpretation of these Official Rules and its exercise of discretion, which will be final and binding in all respects.
2. **SWEEPSTAKES PERIOD AND ENTRY PERIOD(S):** The Sweepstakes begins on or about 8:00:00 AM Central Time (“CT”) on February 2, 2023 and ends on or before 11:59:59 PM CT on March 1, 2023 (the “Sweepstakes Period”); provided, however, the Sweepstakes Period is divided into four (4) entry periods (each, an “Entry Period”), which will begin and end as follows:

The designated computer clock of the Sponsor is the official time-keeping device in the Sweepstakes.

3. **HOW TO ENTER THE SWEEPSTAKES:** There is one (1) method of entry for this Sweepstakes, and you may enter as follows:
 - **Online Method of Entry.** To enter the Sweepstakes, during the Entry Period, you may visit the Sweepstakes website at

info.kubotausa.com/honkytonkconcertticketgiveaway ("Website"). The Website will contain a description of the Sweepstakes and the official entry form. Each entrant will be asked to submit an official entry form, which may include, among other things, his/her/their full name, address, email address and related entry information as prompted. Entrant must complete and submit the entry form with all required information for the entry to be eligible. Any entrant who deletes or requests deletion of the information such entrant provided on the official entry form prior to winner selection will be ineligible to win.

4. **SWEEPSTAKES DRAWING/PRIZE CLAIMING:** There will be four (4) winner(s) selected in this Sweepstakes. The potential winner(s) will be selected through four (4) random drawings, with one (1) random drawing occurring on or about the next business day after the Entry Period End Date. Each potential winner will be selected from the pool of all eligible entries received as of the date of such random drawing and in accordance with these Official Rules. Sponsor will have complete discretion over interpretation of the Official Rules, of administration of the Sweepstakes, and of selection of the winner(s). Decisions of the Sponsor as to the selection of the winner(s) will be final.
5. **ODDS:** Odds of winning a Sweepstakes prize for any date of drawing depend on the total number of eligible entries received as of such date of drawing.
6. **WINNER NOTIFICATION:** The potential prize winners will be notified using the information provided during entry by any of email, telephone, mail (method to be selected by Sponsor in its sole discretion) in a commercially reasonable time after the drawing. The Sweepstakes Parties are not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email, placing of a phone call, or two (2) days after mailing. A potential prize winner who provides a P.O. Box may be required to provide an alternative address and this may cause a delay in notification and acceptance so use of a P.O. Box is discouraged. The Sweepstakes Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email or other account to receive messages.

Each potential winner will be required to submit an affidavit of eligibility / release of liability / prize acceptance agreement (collectively, the "Affidavit") and return the Affidavit within the time period specified at notification before being eligible to receive his or her prize(s). If any potential prize winner fails or refuses to sign and return such Affidavit within the time period required by Administrator or if the prize or prize notification is returned as rejected, faulty, unclaimed or returned as undeliverable to such potential prize winner, such potential prize winner may be disqualified and an alternate may be selected. The Affidavit must be completed, signed and returned to Administrator within three (3) days of date of issuance. Non-compliance shall result in disqualification and award of the prize(s) to an alternate winner. Potential winner becomes a "winner" only after verification of eligibility by Sponsor. If such potential winner cannot be contacted within a reasonable time period, if the potential winner is ineligible, if any notification is returned undeliverable, or if the potential winner otherwise fails to fully comply with these Official Rules, he/she will forfeit that prize and an alternate winner may be selected from among all remaining entries for that drawing. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners, or remaining winners, as the case may be, of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prize(s). Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. The Sweepstakes Parties are not responsible for and shall not be liable for late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify the potential winners.

- **Oklahoma City Trip Prize:** One (1) Oklahoma City Trip Prize will be awarded, consisting of:
 - Two (2) roundtrip economy/coach airline tickets for the winner and one (1) companion via Sponsor-selected air carrier(s) from a major commercial airport selected by Sponsor in its sole and absolute discretion to Oklahmona City, OK
 - One (1)-night hotel stay (one (1) standard room based on double occupancy) for the winner and one (1) companion in Oklahmona City, OK
 - Two (2) tickets to the scheduled Blake Shelton Back To The Honky Tonk Tour concert on March 17, 2023 at 7:00 PM CT (the “Oklahoma City Event”)
 - One (1) Digital Uber gift card to be used for ground transportation
 - One (1) Digital Visa gift card to be used toward meals
 - One (1) Kubota branded gift package

- **Kansas City Trip Prize:** One (1) Kansas City Trip Prize will be awarded, consisting of:
 - Two (2) roundtrip economy/coach airline tickets for the winner and one (1) companion via Sponsor-selected air carrier(s) from a major commercial airport selected by Sponsor in its sole and absolute discretion to Kansas City, MO
 - One (1)-night hotel stay (one (1) standard room based on double occupancy) for the winner and one (1) companion in Kansas City, MO
 - Two (2) tickets to the scheduled Blake Shelton Back To The Honky Tonk Tour concert on March 18, 2023 at 7:00 PM CT (the “Kansas City Event”)
 - One (1) Digital Uber gift card to be used for ground transportation
 - One (1) Digital Visa gift card to be used toward meals
 - One (1) Kubota branded gift package

- **Pittsburgh Trip Prize:** One (1) Pittsburgh Trip Prize will be awarded, consisting of:
 - Two (2) roundtrip economy/coach airline tickets for the winner and one (1) companion via Sponsor-selected air carrier(s) from a major commercial airport selected by Sponsor in its sole and absolute discretion to Pittsburgh, PA
 - One (1)-night hotel stay (one (1) standard room based on double occupancy) for the winner and one (1) companion in Pittsburgh, PA
 - Two (2) tickets to the scheduled Blake Shelton Back To The Honky Tonk Tour concert on March 24, 2023 at 7:00 PM ET (the “Pittsburgh Event”)
 - One (1) Digital Uber gift card to be used for ground transportation
 - One (1) Digital Visa gift card to be used toward meals
 - One (1) Kubota branded gift package

The Louisville Event, Oklahoma City Event, Kansas City Event and Pittsburgh Event may be collectively referred to herein as the "Events", and each, individually, as an "Event".

The average retail value ("ARV") for each Trip Prize is Two Thousand Five Hundred Dollars (\$2,500). The total ARV for all Trip Prizes is Ten Thousand Dollars (\$10,000) (USD). **Actual retail value of each Trip Prize may vary depending on point of departure, travel dates and fare/rate fluctuations.** If the actual value of the prize is less than the stated ARV, the difference will not be awarded. All travel arrangements must be made through the Sponsor or Sponsor's designee. Certain restrictions and blackout dates may apply. If in the judgment of Sponsor air travel is not required due to a winner's proximity to the applicable Trip Prize location, ground transportation will be substituted for roundtrip air travel at Sponsor's sole and absolute discretion. The difference in value will not be awarded to any such Trip Prize winner.

Sponsor shall not be responsible for any cancellations, delays, diversions or substitution or any acts or omissions whatsoever by the air carriers, hotels, venue operators, transportation companies, prize providers or any other persons providing any Trip Prize-related services or accommodations. Sponsor is not liable for any missed prize events, opportunities or expenses incurred as a consequence of flight cancellation/delay or ground transportation delay. No refund or compensation will be made in the event of the cancellation or delay of any transportation or other prize element except at the sole and absolute discretion of Sponsor. Additional prize award details and travel information to be provided to each Trip Prize winner at the time of such Trip Prize notification. Trip Prize winners and companion(s) are responsible for obtaining travel insurance (and all other forms of insurance) at their option and hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance. Any Trip Prize winner may be required to provide a credit card at the time of hotel check-in. Companion(s) of Trip Prize winners must be at least the age of majority in his or her state of residence as of the date of departure. Travel companion(s) must execute liability/publicity releases prior to issuance of travel documents. Once a travel companion is selected by a Trip Prize winner and accepted by Sponsor, he/she may not be substituted, except in Sponsor's sole and absolute discretion. Travel is subject to the terms and conditions set forth in this Sweepstakes, and those set forth by Sponsor's transportation carrier(s) of choice. Lost, stolen or damaged airline tickets, travel vouchers or certificates will not be replaced or exchanged. Address of Event will be provided by the Sponsor a reasonable time prior to the Event. Each winner is advised to arrive at least one (1) hour prior to Event start time. **No one will be admitted without a ticket.** If, for whatever reason, the Event associated with the prize is cancelled after the prize is awarded, Sponsor's liability for the prize is limited only to the non-Event portions of the prize. No compensation will be paid in lieu of the cancelled Event. The tickets to the Event are subject in all respect to the terms and conditions set forth on the tickets and any requirements of the facility hosting the Event. Seat locations (if applicable) will be determined by Sponsor. The winners and companion(s) are strictly prohibited from selling, auctioning, trading or otherwise transferring the tickets unless Sponsor consents in writing. In the event a prize winner (and/or his or her companion (if applicable)) engages in behavior that (as determined by Sponsor or any prize provider in its or their sole and absolute discretion) is obnoxious, inappropriate, or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the applicable Trip Prize experience early. Decisions regarding the conduct of the winner(s) and companion(s) (if applicable) in all aspects of their participation in the Event will be in the sole discretion of Sponsor, and any of Sponsor's representatives and final and binding in all respects. Winner(s) and companion(s) may be removed or disqualified from participating in any aspect of the prize for any reason at any time, including, without limitation, creating an unauthorized disturbance, interruption or unnecessarily rough physical contact, creating the potential for injury or property damages, or for any unhealthy, unsafe, unlawful, or inappropriate act. If a winner or companion who, in the opinion of Sponsor or any of Sponsor's representatives, is considered a physical or mental threat to the well-being of any other individual, he/she may be removed from any premises relating to the prize and winner (and/or companion (if applicable)) consents to such removal.

Prize(s) are non-transferable, with no cash redemptions, equivalents or substitutions except at Sponsor's sole and absolute discretion. ALL PRIZE(S) ARE AWARDED "AS IS" AND WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED (INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE). Prize winner(s) will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prize(s) they receive, regardless of whether they, in whole or in part, are used. The ARV of the prize(s) is based on available information provided to Sponsor and the value of any prize awarded to a winner may be reported for tax purposes as required by law. The winner(s) may be required to provide Sponsor with a valid social security number before the prize(s) will be awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of winner(s) for the actual value of the prize(s) received. Unclaimed prize(s) will be forfeited. Prize(s), if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated or stolen prize(s) or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited and the Sweepstakes Parties will have no further obligation with respect to that prize or portion of that prize. No more than the stated prize(s) will be awarded. The total ARV of all of the prize(s) awarded in this Sweepstakes is Ten Thousand Dollars (\$10,000). The Sweepstakes Parties are not responsible for and winner will not receive the difference, if any, between the actual value of the prize(s) at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material. Limit of one (1) prize per person. The Sweepstakes Parties are not obligated to use the Advertising materials. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes Parties, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor’s control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner.

- 10. WAIVERS AND DISCLAIMERS:** The Sweepstakes Parties assume no responsibility or liability for: (a) lost, late, stolen, undelivered, inaccurate, incomplete, delayed, misdirected, damaged or

garbled registrations, entries, URLs, or emails; (b) any incorrect or inaccurate entry information, or for any faulty or failed electronic data transmissions; (c) any unauthorized access to, or theft, destruction or alteration of entries or registrations at any point in the operation of this Sweepstakes; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (e) inaccessibility or unavailability of the Internet or the website or any combination thereof or for computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, social networking posts, or registrations, the announcement of the prizes, or in any other Sweepstakes-related materials; or (f) any injury or damage to participants or to any other person's computer or other electronic device which may be related to or resulting from any attempt to participate in the Sweepstakes.
